## How The Endangered Species Act Is Helping Sea Turtle Populations Recover

This law fends off the harassing of turtles as well as the permeation of turtle products, which is crucial to the population's flourishing. Additionally, the Endangered Species Act raises awareness about sea turtles by establishing an indispensable connection between the laws protecting species and their habitats. An article on the World Wildlife Foundation says that governments on multiple levels, such as the federal, state, and local governments, all coordinate to further efforts to protect endangered animals (the US Endangered Species Act). The Endangered Species Act

promotes this connection by putting an animal on the endangered species list, knowing that governments in that region will be forced to market the protection of these species. In this case, since sea turtles are so widespread, governments across the nation are required to advance the efforts of sea turtle conservation. Thus, the Endangered Species Act helps protect sea turtles by raising awareness.

Next, the Endangered Species Act helps to preserve and protect sea turtles by promoting conservation efforts. The Endangered Species Act inspires various partnerships between governments and conservancies to protect sea turtles. For example, an article on the U.S. Department of State website tells me that select fisheries have been approved to "have adequate measures in place to protect these sea turtles,"(Schuldheisz). Furthermore, the government works with conservancies to promote growth in sea turtles' populations.
