

## Endangered Species Act Essay

In the source "World Wildlife; The US Endangered Species Act," the author writes, "The law requires protection for critical habitat areas and the development and implementation of recovery plans for Listed species," (World Wildlife). What this means is that the ESA has passed a law that makes it illegal to develop on or destroy critical habitats. This will help give endangered animals a place to live that isn't being destroyed. Furthermore, the same source says, "The rebound of a species is a gradual process that requires a long-term commitment dependent on many factors such as habitat," (World Wildlife). Moreover, the Endangered Species Act protects animals by rescuing and providing care

for injured endangered animals. For example, the MarineLand association takes injured wildlife from the oceans and nurtures them back to health before letting them free. Based on the source "American Humane, Marine Parks," the author writes, "Today, the MarineLand association aims to safeguard marine animals in the wild," (American Humane). This association conducts sea turtle observation campaigns and takes in injured animals to heal. Additionally, The same source says, "Since 2017, the wildlife rehabilitation center of Antibes, created and supervised by the MarineLand association, has already saved 7 turtles, all of which have returned to the Mediterranean Sea," (American Humane). This article was written in 2017, so in a total of 2 years, 7 turtles had been rescued, rehabilitated, saved, and returned to their homes. At that rate, people could keep saving sea turtles until they are no longer endangered. There are organizations like this for other species all around the world. Animals can be saved, even if it's one by one. Organizations that can provide care for endangered species help the ESA to protect endangered animals.

Lastly, the Endangered Species Act protects animals by making it illegal to hunt and harm endangered animals. In the source "World Wildlife, the Endangered Species Act Q&A," the author lists the ways ESA protects species, one way being it "prohibits harming or killing endangered species," (World Wildlife). Animals like rhinos were hunted for their horns and that's the main reason there are only a few left. The ESA has made that illegal and is trying to revive the species. Moreover, the same source states, "The red kangaroo was long hunted for its meat and hide, to the point that it was listed as endangered in 1974," (World Wildlife). This is just one example of hunting causing endangerment. Because it was made illegal to harm or kill animals, red kangaroos were taken off the endangered list by 1995. This law enforced by the ESA will help protect many animals killed by hunting.
